DPW 4/21/94 WITH 2 EXCEPTIONS: 1) LEASE #1 EXCLUDES OLD POINT #566, THIS POINT WAS INCLUDED IN THE WRITTEN DESCRIPTION IN THE 4/21/94 PAPER, BUT EXCLUDED FROM THE ATTACHED MAP, 2) LEASES 8, 9, 10, 11, 12, 13 ARE NUMBERED DIFFERENTLY THAN THE 4/21/94 MAP BECAUSE THE MAP OMITTED OLD POINT #488.

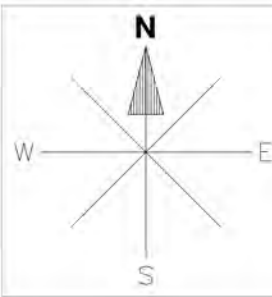
