BE IT ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, that the Code of the Town of Oyster Bay, New York, adopted October 5, 1971, and recodified April 22, 1991, as Chapter 233, as amended, be and the same is further amended as follows:

SYOSSET - Edna Drive - No Parking 9 pm to 6 am - from the left side of the apron at House No. 44 to the right side of the apron at House No. 53.

That the following locations be <u>ADDED</u> to <u>SECTION 17-184</u> of the said Code establishing <u>NO PARKING/STANDING DURING CERTAIN DAYS OR HOURS</u>, which shall be appropriately designated by posted signs: GLEN HEAD - Falmouth Lane - No Parking 8 am to 3 pm School Days - east side - staring at a point 60 feet north of the north curbline of Plymouth Drive South, north for a distance of 125 feet; east side - starting at a point 40 feet north of the north curbline of Salem Way, north for a distance of 45 feet. MASSAPEQUA - Arlyn Drive West - No Parking 9:00 am to 2:30 pm - School Days - west side - starting at a point 159 feet north of the north west curbline of Merrick Road, north for a distance of 74 feet.
