

BE IT ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, that the Code of the Town of Oyster Bay, New York, adopted October 5, 1971, and recodified April 22, 1991, as Chapter 233, as amended, be and the same is further amended as follows:

That the following locations be ADDED to SECTION 17-25 of the said Code establishing thereunder the following intersections as STOP intersections and stop signs shall be erected at appropriate places facing traffic on the stop street. All traffic on a stop street approaching a through street from either direction, unless otherwise designated, shall come to a full stop before entering the through street.

That the following locations be ADDED to SECTION 17-152 of the said Code establishing NO STOPPING ZONES, which shall be appropriately designated by posted signs: BETHPAGE - Spruce Avenue - No Stopping Here to Corner - east side - starting at the north curblineline of Cherry Avenue, north for a distance of 35 feet; west side - starting at the south curblineline of Cypress Avenue, south for a distance of 30 feet. Thorne Drive - No Stopping Anytime - south side - starting at a distance 85 feet from the north curblineline of Central Avenue, west for a distance of 58 feet. HICKSVILLE - Farm Lane - No Stopping Here to Corner - north side - starting at the west curblineline of Broadway, west for a distance of 40 feet. Bunker Lane - No Stopping Here to Corner - west side - starting at the west curblineline of Tip Top Lane, south for a distance of 30 feet. JERICHO - Tioga Drive - No Stopping Here to Corner - south side - starting at the west curblineline of Lewis Avenue, west for a distance of 40 feet. MASSAPEQUA - Ocean Avenue - east side - No Stopping Anytime - starting at a point 252 feet south of the south curblineline of Sunrise Highway south for a distance of 98 feet.

That the following locations be ADDED to SECTION 17-165 of the said Code establishing NO PARKING ANYTIME which shall be appropriately designated by posted signs: FARMINGDALE - Staples Street - No Parking Here to Corner - east side - starting at the north curblineline of Maple Avenue, north for a distance of 30 feet; east side - starting at the south curblineline of Maple Avenue, south for a distance of 30 feet. MASSAPEQUA - Ocean Avenue - No Parking Anytime east side - starting at a point 48 feet south of the south curblineline of Sunrise Highway south for a distance of 204 feet.

That the following locations be DELETED from SECTION 17-165 of the said Code: BETHPAGE - Washington Street - south side - No Parking Loading Zone - starting at a point 86 feet west of the west curblineline of Broadway, west for a distance of 50 feet. HICKSVILLE - Farm Lane - north side - No Parking Anytime - starting at the west curblineline of Broadway, west for a distance of 165 feet. MASSAPEQUA - Ocean Avenue - east side - No Parking Anytime - starting at the south curblineline of Sunrise Highway, south for a distance of 156 feet.

That the following locations be ADDED to SECTION 17-166 of the said Code establishing NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: SYOSSET - Robert Circle - No Parking 7am to 10am except Saturday & Sunday - north side - starting at the northwest curblineline of Honey Drive, west to the westernmost property line of House No. 52.

That the following locations be DELETED from SECTION 17-166 of the said Code: BETHPAGE - Washington Street - No Parking 5am to 9am except Saturday, Sunday and Holidays - south side - starting from a point 30 feet west of the west curbline of Broadway, west for a distance of 75 feet; south side - starting from a point 105 feet west of the west curbline of Broadway, west for a distance of 50 feet.

That the following locations be ADDED to SECTION 17-167 of the said Code establishing LIMITED PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: BETHPAGE - Washington Street - One Hour Parking except Saturday, Sunday and Holidays - south side- starting at a point 30 feet west of the west curbline of Broadway, west for a distance of 167 feet. Municipal Parking Field B-4 - One Hour Parking Except Saturday, Sunday and Holidays - starting from a point 30 feet south of the southwest curbline of Washington Street, south for a distance of 58 feet. MASSAPEQUA - Merrick Road - Two Hour Parking - north side - starting at a point 255 feet west of the west curbline of Forest Avenue, west for a distance of 145 feet; north side - starting at a point 164 feet west of the west curbline of Forest Avenue, west for a distance of 55 feet.

That the following location be DELETED from SECTION 17-167 of the said Code: MASSAPEQUA - Merrick Road - Two Hour Parking - north side - starting at a point 94 feet west of the west curbline of Forest Avenue, west for a distance of 540 feet.
