

Meeting of

BE IT ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, that the Code of the Town of Oyster Bay, New York, adopted October 5, 1971, and recodified April 22, 1991, as Chapter 233, as amended, be and the same is further amended as follows:

That the following locations be ADDED to SECTION 17-25 of the said Code establishing thereunder the following intersections as STOP intersections and stop signs shall be erected at appropriate places facing traffic on the stop street. All traffic on a stop street approaching a through street from either direction, unless otherwise designated, shall come to a full stop before entering the through street.

That the following location be ADDED to SECTION 17-44 of the said Code, establishing LEFT OR RIGHT TURNS SHALL OR SHALL NOT BE MADE, which shall be appropriately designated by posted signs: SYOSSET: Berry Hill Road - No Left Turn 6am to 10am Monday through Friday - southbound traffic shall be prohibited from turning left onto East Street. Berry Hill Road - No Left Turn - 6am to 10am and 3pm-9pm except school buses - southbound traffic shall be prohibited from turning left onto Renee Road, except school buses. Cold Spring Road - No Left Turn - 6am-10am and 3pm-9pm except school buses - northbound traffic shall be prohibited from turning left onto Renee Road, except school buses.

That the following location be DELETED from SECTION 17-44 of the said Code: SYOSSET: Berry Hill Road - No Left Turn 6am to 8am Monday through Friday - southbound traffic shall be prohibited from turning left onto East Street.

That the following locations be ADDED to SECTION 17-45 of the said Code, establishing NO U TURNS, which shall be appropriately designated by posted signs: HICKSVILLE: 4th Street - north side opposite 5th Avenue; south side 40 feet east of the east curbline of Jerusalem Avenue (between Jerusalem Avenue and 5th Avenue).

That the following locations be ADDED to SECTION 17-152 of the said Code establishing NO STOPPING ZONES, which shall be appropriately designated by posted signs: BETHPAGE - Enness Avenue - No Stopping Here to Corner - north side - starting at the east curbline of Stewart Avenue, east for a distance of 35 feet; south side - starting at the east curbline of Stewart Avenue, east for a distance of 35 feet. PLAINVIEW - Ruby Lane - No Stopping Here to Corner - north side- starting at the east curbline of Opal Drive, east for a distance of 30 feet. Northern Parkway - No Stopping Here to Corner - south side - starting from the west curbline of Wood Lane, west for a distance of 35 feet. SYOSSET - Robbins Lane - No Stopping Here to Corner - north side - starting at the north/west curbline of the northwestern most driveway exit of Robbins Lane School, west for a distance of 35 feet. Renee Road - No Stopping Here to Corner - north side - from the east curbline of Berry Hill Road, east for a distance of 60 feet; south side - from the east curbline of Berry Hill Road, east for a distance of 60 feet. Jackson Avenue - No Stopping Here to Corner - west side - starting at the north curbline of the southernmost entrance of Lucille Drive, north for a distance of 75 feet. Ira Road - No Stopping Here to Corner - north side - starting at the west curbline of Edward Lane, west for a distance of 40 feet.

That the following locations be DELETED from SECTION 17-152 of the said Code: SYOSSET - Renee Road - No Stopping Here to Corner - north side - from the east curbline of Berry Hill Road, east for a distance of 40 feet; south side- from the east curbline of Berry Hill Road, east for a distance of 40 feet.

That the following location be ADDED to SECTION 17-153 of the said Code establishing NO STOPPING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: SYOSSET - Jackson Avenue - No Stopping 7am to 2pm Sundays - west side - starting at a point 75 feet north of the southernmost (north) curbline of Lucille Drive, north to the (south) curbline of the northernmost curbline of Lucille Drive.

That the following location be DELETED from SECTION 17-153 of the said Code: SYOSSET - Jackson Avenue - No Stopping 7am to 2pm Sundays - west side - starting at the south curbline of Lucille Drive (north)- south to the north curbline of Lucille Drive (south).

That the following locations be ADDED to SECTION 17-165 of the said Code, establishing No Parking Zones, which shall be appropriately designated by posted signs: HICKSVILLE - East Nicholai Street - No Parking Anytime - south side - east and west of both the driveway entrance/exits to St. Ignatius Parish for a distance of 10 feet; East Cherry Street - north side - east and west of both the driveway entrance/exits to St. Ignatius Parish for a distance of 10 feet.

That the following locations be ADDED to SECTION 17-166 of the said Code establishing NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: HICKSVILLE - Fifth Street - No Parking 8am to 4pm School Days - north side - starting at a point 330 feet east of the east curbline of Division Avenue, on the easternmost property line of House #178, east to a point 105 feet west of the west curbline of Jerusalem Avenue. Halsey Avenue - No Parking 8am to 4pm School days - west side - starting at a point 137 feet south of the south curbline of Second Street, south to its southern termination. PLAINVIEW - Ruby Lane - No Parking 9am to 4pm except Saturday, Sunday & Holidays - north side- starting at a point 92 feet east of the east curbline of Opal Drive, east for a distance of 58 feet. OYSTER BAY - Agnes Street - No Parking 8am to 4pm School Days - north side - starting at a point 40 feet east of the east curbline of McCouns Lane, east for a distance of 71 feet; north side - starting at the west curbline of Sandy Hill Road, west for a distance of 240 feet; south side - starting at a point 147 feet west of the west curbline of Sandy Hill Road, west for a distance of 72 feet. SYOSSET - Ira Road - No Parking 10am to 12pm, except Saturday, Sunday and Holidays - north side- starting at a point 831 feet west of the west curbline of Edward Lane, west for a distance of 69 feet; north side - starting at a point 686 feet west of the west curbline of Edward Lane, west for a distance of 145 feet. Ira Road - No Parking 10am to 12pm except Saturday, Sunday and Holidays - north side - starting at a point 970 feet west of the west curbline of Edward Lane, west for a distance of 75 feet. Miller Boulevard - No Parking 10am to 12pm, except Saturday, Sunday and Holidays - north side - starting at the west property line of House No. 43, east to the west property line of House No. 45; north side - starting at the west property line of House No. 45, east to the west property line of House No. 47; north side - starting at the west property line of House No. 51, east to the east property line of house No. 51.

That the following locations be DELETED from SECTION 17-166 of the Said Code: HICKSVILLE - Halsey Avenue - No Parking 8am to 4pm School Days - west side - starting at a point 157 feet south of the south curbline of Second Street, south to its southern termination. Fifth Street - No Parking 8am to 4pm School Days - north side - starting at a point 273 feet east of the east curbline of Division Avenue, east to a point 105 feet west of the west curbline of Jerusalem Avenue. PLAINVIEW - Ruby Lane - No Parking 9am to 4pm except Saturday, Sunday & Holidays - north side - starting at the east curbline of Opal Drive, east for a distance of 150 feet. SYOSSET Ira Road - No Parking 8am to 10 am except Saturday, Sunday and Holidays - north side - starting at a point 831 feet west of the west curbline of Edward Lane, west for a distance of 69 feet; north side - starting at a point 686 feet west of the west curbline of Edward Lane, west for a distance of 145 feet; north side - starting at a point 110 feet west of the west curbline of Edward Lane, west for a distance of 230 feet.

That the following location be ADDED to SECTION 17-167 of the said Code, establishing LIMITED PARKING ZONES, which shall be appropriately designated by posted signs: MASSAPEQUA - Merrick Road - Two Hour Parking - south side - starting at a point 214 feet west of the west curbline of Unqua Road, west for a distance of 52 feet.

That the following locations be ADDED to SECTION 17-168 of the said Code establishing LIMITED PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: OYSTER BAY - Audrey Avenue - Three Hour Parking 8am to 6pm except Saturday, Sunday & Holidays - east side - starting at the south curbline of Railroad Avenue, south for a distance of 275 feet; east side - starting at a point 275 feet south of the south curbline of Railroad Avenue, south for a distance of 31 feet.

That the following locations be DELETED to SECTION 17-168 of the said Code: OYSTER BAY - Audrey Avenue - Two Hour Parking 8am to 6pm except Saturday, Sunday & Holidays - east side - starting at the south curbline of Railroad Avenue, south for a distance of 275 feet; east side - starting at a point 275 feet south of the south curbline of Railroad Avenue, south for a distance of 31 feet.

That the following location be ADDED to SECTION 17-184 of the said Code establishing: NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: HICKSVILLE - Acre Lane - No Parking 8pm to 8am - east side - starting at the northernmost property line of #1 Abbot Lane (side property), north for a distance of 100 feet.

That the following location be DELETED to SECTION 17-184 of the said Code: HICKSVILLE - Acre Lane - No Parking 8pm to 8am - east side - starting at the northernmost property line of House #2, north for a distance of 100 feet.
