

BE IT ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, that the Code of the Town of Oyster Bay, New York, adopted October 5, 1971, and recodified April 22, 1991, as Chapter 233, as amended, be and the same is further amended as follows:

That the following locations be ADDED to SECTION 17-25 of the said Code establishing thereunder the following intersections as STOP intersections and stop signs shall be erected at appropriate places facing traffic on the stop street. All traffic on a stop street approaching a through street from either direction, unless otherwise designated, shall come to a full stop before entering the through street.

That the following location be DELETED from SECTION 17-25 of the said Code:

That the following location be ADDED to SECTION 17-28 of the said Code establishing YIELD intersections, which shall be appropriately designated by posted signs:

WOODBURY	South Woods Road	Cold Spring Road, southbound

That the following locations be ADDED to SECTION 17-152 of the said Code establishing NO STOPPING ZONES, which shall be appropriately designated by posted signs:

BETHPAGE - Burkhardt Avenue - No Stopping Here to Corner - south side - starting at the east curblineline of South 2nd Street, east for a distance of 23 feet.

Enness Avenue - No Stopping Here to Corner - north side - starting at west curblineline of Iram Place, west for a distance of 30 feet.

HICKSVILLE - Kenneth Court - No Stopping Here to Corner - south side - starting from the west curblineline of Miller Road, west for a distance of 40 feet.

Heitz Place - No Stopping Here to Corner - south side - starting from the west curblineline of East Street, west for a distance of 50 feet; north side - starting from the west curblineline of East Street, west for a distance of 35 feet.

East Street - No Stopping Here to Corner - west side - starting from the south curblineline of Heitz Place, south for a distance of 50 feet.

MASSAPEQUA - Forest Avenue - No Stopping Here to Corner - west side - starting at the north curblineline of Jackson Place, north for a distance of 45 feet; west side - starting at the south curblineline of Jackson Place, south for a distance of 45 feet.

Boston Avenue - No Stopping Here to Corner - north side - starting at the west curblineline of Broadway, west for a distance of 30 feet; south side - starting at the west curblineline of Broadway, west for a distance of 35 feet.

Rhode Island Avenue - No Stopping Here to Corner - south side - starting at the west curblineline of Broadway, west for a distance of 40 feet; north side - starting at the west curblineline of Broadway, west for a distance of 50 feet.

SYOSSET - Church Street - No Stopping Here to Corner - north side - starting at the west curblineline of Berryhill Road, west for a distance of 40 feet; south side - starting at the east curblineline of Split Rock Road, east for a distance of 35 feet.

Florence Avenue - No Stopping Here to Corner - west side - starting from the south curblineline of Edward Avenue, south for a distance of 20 feet.

That the following locations be DELETED from SECTION 17-152 of the said Code: MASSAPEQUA - Rhode Island Avenue - No Stopping Here to Corner - south side - starting at the west curblineline of Broadway, west for a distance of 24 feet; north side - starting at the west curblineline of Broadway, west for a distance of 24 feet.

That the following location be ADDED to SECTION 17-153 of the said Code establishing NO STOPPING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: HICKSVILLE - Kingston Avenue - No Stopping 8am to 4 pm except Saturday, Sunday and Holidays - north side - starting at the west curblineline of Cortland Avenue, west to a point 40 feet east of the east curblineline of West Avenue.

That the following location be DELETED from SECTION 17-153 of the said Code: HICKSVILLE - Kingston Avenue - No Stopping 8 am to 4 pm except Saturday, Sunday and Holidays - north side - starting at the west curblineline of Cortland Avenue, west for a distance of 134 feet.

That the following locations be ADDED to SECTION 17-165 of the said Code, establishing No Parking Zones, which shall be appropriately designated by posted signs: OYSTER BAY - Orchard Street - No Parking Anytime - north side - opposite House No. 95, west of driveway for a distance of 20 feet; north side - opposite House No. 95, east of driveway for a distance of 20 feet. PLAINVIEW - Barnum Avenue - No Parking Anytime - east side - opposite House No. 68, north of Driveway for a distance of 16 feet; east side - opposite House No. 68, south of driveway for a distance of 16 feet. SYOSSET - Church Street - No Parking Anytime - north side - starting at the east curblineline of Split Rock Road, east for a distance of 175 feet. Edward Avenue - No Parking Anytime - north side - starting at a point 177 feet west of the west curblineline of Jackson Avenue, west for a distance of 78 feet.

That the following locations be DELETED to SECTION 17-165 of the said Code: SYOSSET - Church Street - No Parking Anytime - north side - starting at the west curblineline of Berryhill Road, west to the east curblineline of Split Rock Road.

That the following locations be ADDED to SECTION 17-166 of the said Code establishing NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: GLEN HEAD - Ellen Court - No Parking 9am to 3 pm School Days - west side - starting at a point 112 feet south of the south curblineline of Todd Drive North, south then west for a distance of 175 feet. HICKSVILLE - Heitz Place - No Parking 8:30 am to 9:30 am and 3:00 pm to 4:00 pm School Days Except School Buses - south side starting at point 50 feet west of the west curblineline of East Street, west for a distance of 200 feet. SYOSSET - North Street - No Parking 8am to 10 am Except Saturday, Sunday and Holidays - east side - starting at the north curblineline of Church Street, north to the south curblineline of Woodbury Way; west side - starting at the north curblineline of Church Street, north to the northern-most property line of House No. 35 North Street. Edward Avenue - No Parking Thursday through Saturday - north side - starting at a point 30 feet east of the east curblineline of Humphrey Drive, east for a distance of 105 feet; Humphrey Drive - No Parking Thursday through Saturday - east side - starting at the north curblineline of Edward Avenue, north for a distance of 54 feet; east side - starting at a point 122 feet north of the north curblineline of Edward Avenue, north for a distance of 62 feet. Ira Road - No Parking 8 am to 10 am except Saturday Sunday and Holidays - north side - starting at a point 618 feet west of the west curblineline of Edward Lane, west for a distance of 68 feet.

That the following locations be DELETED from SECTION 17-166 of the Said Code: FARMINGDALE - Beach Street - No Parking 11 pm to 8 pm - east side - starting at the north curblineline of Spencer Street, north for a distance of 330 feet. SYOSSET - Edward Avenue - No Parking 10 am to 2 pm except Saturday, Sunday and Holidays - north side - starting at a point 40 feet east of the east curblineline of Humphrey Drive, east for a distance of 70 feet. Edward Avenue - No Parking 8 am to 5 pm, except Saturday, Sunday and Holidays - north side - starting at a point 177 feet west of the west curblineline of Jackson Avenue, west for a distance of 78 feet.

That the following locations be ADDED to SECTION 17-167 of the said Code, establishing LIMITED PARKING ZONES, which shall be appropriately designated by posted signs: MASSAPEQUA - Boston Avenue One Hour Parking - north side - starting at a point 30 feet west of the west curblineline of Broadway, west for a distance of 45 feet. SYOSSET - Two Hour Parking - north side - starting at a point 40 feet west of the west curblineline of Berryhill Road, west for a distance of 168 feet.

That the following locations be ADDED to SECTION 17-168 of the said Code establishing LIMITED PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: BETHPAGE - Burkhardt Avenue - Four Hour Parking 8 am to 4 pm except Saturday, Sunday and Holidays - north side - starting at a point 74 feet west of the west curblineline of S. 1st Street, west for a distance of 132 feet. HICKSVILLE - Woodbury Road - One Hour Parking except Sunday - south side - starting at a point 144 feet west of the west curblineline of Harding Avenue, west for a distance of 33 feet. JERICHO - Sixteenth Street - Two Hour Parking 9am to 2 pm north side - starting at the west curblineline of Valerie Avenue, west for a distance of 60 feet. Valerie Avenue - Two Hour Parking 9 am to 2 pm - west side - starting at the north curblineline of Sixteenth Street, north for a distance of 75 feet.

That the following locations be DELETED to SECTION 17-168 of the said Code: BETHPAGE - Burkhardt Avenue - Four Hour Parking 8 am to 4 pm except Saturday, Sunday and Holidays - north side - starting at a point 74 feet west of the west curblineline of S. 1st Street, west for a distance of 51 feet.

That the following location be ADDED to SECTION 17-183 of the said Code establishing: NO PARKING OR STANDING, which shall be appropriately designated by posted signs: FARMINGDALE - Beach Street - No Parking Anytime - east side - starting at a point 153 feet from the north curblineline of Spencer Street, north for a distance of 147 feet. MASSAPEQUA - Bertha Lane - No Parking Anytime - north side - starting at the east curblineline of Block Boulevard, east for a distance of 33 feet.
