

BE IT ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, that the Code of the Town of Oyster Bay, New York, adopted October 5, 1971, and recodified April 22, 1991, as Chapter 233, as amended, be and the same is further amended as follows:

That the following locations be ADDED to SECTION 17-25 of the said Code establishing thereunder the following intersections as STOP intersections and stop signs shall be erected at appropriate places facing traffic on the stop street. All traffic on a stop street approaching a through street from either direction, unless otherwise designated, shall come to a full stop before entering the through street.

That the following location be DELETED from SECTION 17-44 of the said Code: SYOSSET - Burke Lane - No Right Turn - westbound traffic from the egress Driveway of the indoor Facility Shall be prohibited from Turning Right onto Burke Lane.

That the following locations be ADDED to SECTION 17-152 of the said Code establishing NO STOPPING ZONES, which shall be appropriately designated by posted signs: BETHPAGE - Powell Avenue - No Stopping Here to Corner - south side - starting from the west curblineline of Cambridge Avenue, west for a distance of 35 feet; south side - starting from the west curblineline of Concord Avenue, west for a distance of 43 feet. HICKSVILLE - Jerusalem Avenue - No Stopping Here to Corner - east side - starting from the north curblineline of Harnat Court, north for a distance of 35 feet. Harnat Court - No Stopping Here to Corner - south side - starting from the east curblineline of Jerusalem Avenue, east for a distance of 35 feet. Lawrence Street - No stopping Here to Corner - west side - starting from the north curblineline of Harnat Court, north for a distance of 35 feet. Charlotte Avenue - No Stopping Here to Corner - east side - starting at the north curblineline of Old Country Road, north for a distance of 70 feet; No Stopping Anytime - east side - starting at a point 70 feet north of the north curblineline of Old Country Road, north to the south curblineline of Duffy Avenue.

Second Street - No Stopping Here to Corner - southwest side - starting from the extended west curbline of Jerusalem Avenue, west to a point 50 feet of said extended curbline; northeast side - from extended east curbline of Jerusalem Avenue, east to a point 55 feet of said extended curbline; Fourth Street - No Stopping Here to Corner - southwest side - from extended west curbline of Jerusalem Avenue, west to a point 50 feet of said extended curbline. Seventh Street - No Stopping Here to Corner - southwest side - from extended west curbline of Jerusalem Avenue, west to a point 55 feet of said extended curbline; northeast side - from extended east curbline of Jerusalem Avenue, east to a point 70 feet of said extended curbline. Tenth Street - No Stopping Here to Corner - southwest side - from extended west curbline of Jerusalem Avenue, west to a point 50 feet of said extended curbline; northeast side - from extended east curbline of Jerusalem Avenue, east to a point 55 feet of said extended curbline. Maglie Drive - No Stopping here to Corner - northeast side - from extended east curbline of Jerusalem Avenue, east to a point 50 feet of said extended curbline. Winding Road - No Stopping Here to Corner - southwest side - from extended west curbline of Jerusalem Avenue, west to a point 45 feet of said extended curbline. Service Road to Winding Road - No Stopping Here to Corner - west side - from extended south curbline of Winding Road, south to a point 35 feet of said extended curbline. MASSAPEQUA - Rhode Island Avenue - No Stopping Here to Corner - north side - starting at the east curbline of Broadway east for a distance of 53 feet. PLAINVIEW - Northern Parkway - No Stopping Here to Corner - south side - starting from the east curbline of Wood Lane, east for a distance of 35 feet. SYOSSET - Whitman Avenue - No Stopping Here to Corner - west side - starting at the south curbline of Willets Avenue, south for a distance of 35 feet. Burke Lane - No Stopping Anytime - east side - starting at a point 247 feet north of the north curbline of Jericho Turnpike, north for a distance of 30 feet; east side - starting at a point 527 feet north of the north curbline of Jericho Turnpike, north for a distance of 108 feet.

That the following locations be DELETED from SECTION 17-152 of the said Code: HICKSVILLE - Maglie Drive - No Stopping Here to Corner - north side - starting at the east curbline of Jerusalem Avenue, east for a distance of 30 feet. Charlotte Avenue - No Stopping Anytime - east side - starting at the north curbline of Old Country Road, north for a distance of 32 feet; east side - starting from the north curbline of Old Country Road, north to Duffy Avenue. MASSAPEQUA - Rhode Island Avenue - No Stopping Here to Corner - north side - starting at the east curbline of Broadway, east for a distance of 20 feet. SYOSSET - Burke Lane - No Stopping Anytime - east side - starting at a point 180 feet north of the north curbline of Jericho Turnpike, north for a distance of 255 feet.

That the following location be ADDED to SECTION 17-153 of the said Code establishing NO STOPPING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: SYOSSET - Burke Lane - No Parking 7am to 4pm, except Saturday, Sunday and Holidays - west side - starting at a point 535 feet north of the north curbline of Jericho Turnpike, north for a distance of 117 feet.

That the following location be ADDED to SECTION 17-165 of the said Code, establishing NO PARKING ZONES, which shall be appropriately designated by posted signs: SYOSSET - Edward Avenue - No Parking Anytime - north side - starting at a point 120 feet west of the west curbline of Jackson Avenue, west for a distance of 50 feet.

That the following locations be ADDED to SECTION 17-166 of the said Code establishing NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: HICKSVILLE -Fifth Street - No Parking 8am to 4pm School Days - south side - starting at a point 165 feet west of the west curblineline of Jerusalem Avenue, west for a distance of 60 feet. Herzog Place - No Parking 9am to 5pm Sundays - south side - starting at a point 120 feet west of the west curblineline of South Broadway, west for a distance of 50 feet. MASSAPEQUA - West Shore Drive - No Parking 8am to 6pm except Saturday, Sunday and Holidays - west side - starting at a point 120 feet south of the west curblineline of Merrick Road, south for a distance of 62 feet. Grove Street - No Parking 9am to 5pm except Sunday and Holidays - south side - starting at a point 175 feet east of the east curblineline of Seaford Avenue, east for a distance of 60 feet. OYSTER BAY - White Street - No Parking 8am to 4pm except Saturday, Sunday and Holidays - east side - starting at a point 140 feet north of the north curblineline of East Main street, north for a distance of 75 feet.

That the following location be DELETED from SECTION 17-166 of the Said Code: HICKSVILLE - Fifth Street No Parking 8am to 4pm School Days - south side - starting at a point 105 feet west of the west curblineline of Jerusalem Avenue, west for a distance of 120 feet. Fourth Street - No Parking 8am to 2pm School Days - south side - starting at the west curblineline of Jerusalem Avenue, west to the east curblineline of Division Avenue.

That the following locations be ADDED to SECTION 17-168 of the said Code establishing LIMITED PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: HICKSVILLE - East Cherry Street - One Hour Parking 9am to 12pm except Saturday, Sunday and Holidays - west side - starting at the south curblineline of Kraemer Street, south to the dead end termination. Second Street - Two Hour Parking 8am to 4pm School Days - south side - starting at a point 50 feet west of the extended curblineline, west to the east curblineline of Division Avenue. Fourth Street - Two Hour Parking 8am to 2pm School Days -south side - starting at a point 50 feet west of the extended west curblineline of Jerusalem Avenue, west to the east curblineline of Division Avenue. SYOSSET - Arizona Avenue - Two Hour Parking 9am to 5pm except Saturday, Sunday and Holidays - south side - starting at a point opposite the west curblineline of Montana Court, west for a distance of 62 feet.

That the following locations be DELETED to SECTION 17-168 of the said Code: BETHPAGE - Railroad Avenue - Two Hour Parking 8am to 4pm except Saturday, Sunday and Holidays - north side - starting at the north curblineline of Burkhardt Avenue, west to the east curblineline of South Fourth Street. HICKSVILLE - Second Street - Two Hour Parking 8am to 4pm School Days - south side - starting at the west curblineline of Jerusalem Avenue, west to the east curblineline of Division Avenue. Fourth Street - No Parking 8am to 2pm School Days - south side - starting at the west curblineline of Jerusalem Avenue, west to the east curblineline of Division Avenue.

That the following location be ADDED to SECTION 17-184 of the said Code establishing: NO PARKING DURING CERTAIN DAYS OR HOURS, which shall be appropriately designated by posted signs: BETHPAGE - Ennis Avenue - No Parking 8am to 10am except Saturday, Sunday and Holidays - north side - starting at the east curblineline of Iram Place, east for a distance of 93 feet. Iram Place - No Parking 8am to 10am except Saturday, Sunday and Holidays - east side - starting at the north curblineline of Ennis Avenue, south for a distance of 83 feet. HICKSVILLE - Second Street - No Parking School Days 7am to 8:30 am - north side - starting from a point 55 feet east of the extended east curblineline of Jerusalem Avenue, east to the west curblineline of Sterling Place. SYOSSET - Nathan Court - No Parking 10am to 12pm except Saturday, Sunday and Holidays - west side - starting at a point 235 feet south of the south curblineline of Ira Road, south for a distance of 45 feet.

That the following location be DELETED to SECTION 17-184 of the said Code: HICKSVILLE - Second Street - No Parking School Days 7am to 8:30 am - north side - starting at the east curbline of Jerusalem Avenue, east to the west curbline of Sterling Place.

That the following location be ADDED to SECTION 17-215 of the said Code establishing: No Trucks Over 4 Tons Gross Weight except Local Delivery, which shall be appropriately designated by posted signs: BETHPAGE - Laurel Place - north side - No Trucks Over 4 Tons Gross Weight except Local Delivery - 20 feet west of the west curbline of Sheridan Avenue. GLEN HEAD - Scudders Lane - No Trucks Over 4 Tons Gross Weight, Except Local Delivery - from the west curbline of Glen Cove Avenue, west to the east curbline of Cody Avenue.
