NIGHT FISHING PERMIT

All individuals wishing to night fish (7PM to 7AM) within the Town of Oyster Bay MUST obtain a permit prior to doing so. There will be **NO** in-person applications, please return the completed application and required documents to the Beaches Division at the address above or email it to beaches@oysterbay-ny.gov. Permits expire at the end of the year, applicants must reapply annually. Permits will be mailed once processed, please allow 5 to 10 business days for your physical permit(s) to arrive in the mail.

Night fishing is permitted at the following locations throughout the Town, during the following dates:

January 1, 2022 through December 31, 2022

Harry Tappen Beach (Glenwood Landing)
Theodore Roosevelt Beach (Oyster Bay)
Centre Island Beach (Bayville)

April 1, 2022 through December 12, 2022

TOBAY Beach (Massapequa)

RULES AND REGULATIONS

- 1) In addition to the Town's rules and regulations, applicants must adhere to all NYS DEC fishing laws and regulations. To check current regulations in effect, please visit www.dec.ny.gov.
- 2) All applicants must provide a valid NYS Recreational Marine Fishing Registration card. Residents may purchase their sporting licenses and permits via the New York State Department of Environmental Conservation (DEC) DECALS, DEC Automated Licensing System, at both Town Clerk offices, 54 Audrey Avenue, Oyster Bay, and 977 Hicksville Road, Massapequa, during regular office hours, 9 AM to 4:45 PM. Please note the Town Clerks office will no longer be able to mail out renewal applications to residents.
- 3) Permit(s) are valid between the hours of 7PM and 7AM in parking lots for the purpose of accessing parking at Harry Tappen Beach, Theodore Roosevelt Beach, Centre Island Beach and TOBAY Beach for night fishing ONLY. A seasonal beach parking sticker or daily parking pass must be purchased during hours of collection at all locations when applicable.
- 4) Each resident with a current night fishing permit will be able to sponsor one non-resident. Resident sponsors will be held responsible for the non-resident's decorum while using Town facilities. All permit holders must observe Town of Oyster Bay Ordinances.
- 5) Automobiles and other vehicles are not permitted beyond the parking lot.
- 6) Permit(s) are not transferrable and may ONLY be used by the designated permit holder for the purpose specified.
- 7) Night Fishing Permit(s) DO NOT substitute any additional requirements of New York State in regards to night fishing.
- 8) For the purpose of identification, permit(s) and corresponding wallet identification card **MUST** be carried on your person and be available if requested by a police officer or Town employee.
- 9) The vehicle identification parking permit must be displayed on the dashboard of the registered car while parking in Town lots where night fishing is permitted. Parking permits are valid ONLY for the vehicle bearing the license plate number indicated on the front of the permit.
- 10) Anglers are encouraged to only harvest fish they intend to eat or use proper catch-and-release practices.
- 11) Applicants must abide by harvest limits and sporting regulations. Permit holders are responsible for checking and following regulations for harvest limits and seasons before going fishing.
- 12) Shark fishing, crabbing, shell fishing and clamming are not covered by the Night Fishing Permit.
- 13) Cleaning of fish should be done at home, not on the docks. The disposal of fish waste in the Town facility will be considered littering. Any person(s) committing an offense shall be guilty of a violation and punishable by a fine.
- 14) Fishing is prohibited in designated swimming areas and Town of Oyster Bay Marinas. Proper distance (50') must be maintained from swimmers and other beach patrons. Ample room should be maintained between other anglers.

15) All Town of Oyster Bay Ordinances are to be observed, with a concentration on the following:

- **168-5** - Any persons using a Town Facility shall conduct themselves in an orderly manner and shall endeavor to cause no discomfort or inconvenience to any other person or patron.
- **168-12** - Swimming is prohibited in the Marina.
- **168-17** - Barbecuing permitted in designated areas only. No fuel except for charcoal or Sterno (gel chafing fuel) may be used.
- **168-19** - Absolutely no animals of any kind are permitted in any Town of Oyster Bay Park, beach, or boating facility.
- **168-27.1** - Any person committing an offense prohibited by a Town of Oyster Bay Ordinance OR these rules and regulations shall be subject to a fine of not less than \$250.00 and/or loss of all present and future boat basin privileges. Summonses will be issued to vessel owners who have not paid the required fee.
- **241-38** - Discharge of materials which may endanger lives or property or the quality of water or the quality of aquaculture or the quality of the environment shall be prohibited. The discharge, in any quantity, of any oil, gasoline, paint, solvent, paint thinner, lubricant, hydrocarbon materials, untreated sewage, litter, pollutants, or any similar type of materials in the waters of the Town of Oyster Bay is prohibited. Violation of either one of these ordinances shall be a misdemeanor and the violator subject to severe fines.
