A local law entitled "A LOCAL LAW TO AMEND THE CODE OF THE TOWN OF OYSTER BAY, NEW YORK, AMENDING CHAPTER 183 – PUBLIC ASSEMBLY, PLACES OF, TO SET FORTH PENALTIES ALLOWED TO BE ASSESSED BY THE BUREAU OF ADMINISTRATIVE ADJUDICATION."

Be it enacted by the Town Board of the Town of Oyster Bay as follows

SECTION 1. Amend Chapter 183-Public Assembly, Places of, to read as follows:

§ 183-22 Penalties for offenses.

- A. Any person who shall conduct, maintain or use any property as a place of assembly or who shall allow, let, suffer or permit any property to be conducted, maintained or used as a place of assembly without a license as provided in this chapter or who shall violate any of the provisions of this chapter shall be deemed to have committed a violation; and for each violation shall be subject to a fine not exceeding \$1000 or imprisonment not in excess of 15 days.
- B. Any person or entity found by the Bureau of Administrative Adjudication to have violated any provision of this chapter is likewise subject to a monetary penalty within the range of fines authorized in this section.

SECTION 2. SEQR Determination. It is hereby determined pursuant to the provisions of the State Environmental Quality Review Act, 8 N.Y.E.C.L. Section 101 et seq. and its implementing regulations, Part 617 of 6 N.Y.C.R.R., that the adoption of this local law is a "Type II" Action within the meaning of Section 617.5 (c)(26) of 6 N.Y.C.R.R., pertaining to "routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment" and, accordingly, is of a class of actions which do not have a significant effect on the environment and no further review is required.

<u>SECTION 3.</u> Severability. If any section, subdivision or provision of this local law or the application thereof to any person or circumstance be adjudged invalid by a court of competent jurisdiction, such judgment shall be confined in its operation to the section, subdivision or provision of or application directly involved in the controversy in which such judgment shall have

been rendered and shall not affect or impair the validity of the remainder of this local law, or the application thereof to other persons or circumstances.

SECTION 4. Effective Date. This local law shall take effect immediately upon its adoption and filing with the Office of the Secretary of State.
