- → All children must be pre-registered prior to enrolling.
- → Pre-Registration will take place from Monday, January 13 Friday, March 21.
- → Parents will receive instructions for final registration this spring. Refunds are prorated and subject to 10% administrative fee through Friday, July 11, 2025. No refunds will be given after July 11, 2025



NY State Sanitary Code Subport 1-2 requires camp operators to provide parents with any enrollment application forms the rights and responsibilities of camp operators:

1) To inform you and the local health department if your child is involved in any serious injury, illness or abuse incident 2) To screen the background and qualifications of all staff 3) To trair staff about their duties 4) To provide supervision during hours of operation for day camps 5) To maintain all camp physical facilities in a safe and sanitary condition 6) To provide safe and wholesome meals 7) To have and follow required written plans for camp safety, health and fire safety. The Summer Recreation Program is permitted to operate by the Nassau County Department of Health, who is required to inspect our camp twice a year - the inspection reports are filed at 200 County Seat Drive, Mineola, NY 11501. Nassau County DOH will only inspect camps that will be swimming.

# Pre-register now - Upload your materials today!

- 1. Parents/guardians must visit: www.oysterbaytown.com/ parksportal
- 2. Select My Account on the top right corner and log-in or create a new account (if your child was registered for the 2024 Summer Program, you already have an account, however documents must be uploaded each year).
- 3. After logging in, select My Account, then Household & Member. Confirm all family members are listed. If needed, select 'Add Family member' at bottom of page and add a child or guardian to the household. Then save.
- 4. Select **Document Upload** from the portal menu. Each document must be uploaded as a separate file (make sure all scanned documents are legible).
