- All children must be pre-registered prior to enrolling.
- Pre-registration runs now through Friday, March 27.
- Parents will receive instructions for final registration this spring. Refunds are prorated and subject to 10% administrative fee through Friday, July 10, 2026. No refunds will be given after July 10, 2026.



*NY State Sanitary Code Subpart 7-2 requires camp operators to provide parents with any enrollment application forms the rights and responsibilities of camp operators: 1) To inform you and the local health department if your child is involved in any serious injury, illness or abuse incident 2) To screen the background and qualifications of all staff 3) To train staff about their duties 4) To provide supervision during hours of operation for day camps 5) To maintain all camp physical facilities in a safe and sanitary condition 6) To provide safe and wholesome meals 7) To develop, follow, and share approved camp safety plans 8) To provide you written notification during enrollment that: The Summer Recreation Camp is required to be permitted to operate by the Nassau County Department of Health; the camp is required to be inspected twice yearly; and the inspection reports and required plans concerning such a camp are available for review at: 200 County Seat Drive, Mineola, New York 11501

Pre-Register Now!

1. Parents/guardians must visit: www.oysterbaytown.com/parksportal
2. Select **My Account** on the top right corner and log-in or create a new account (*if your child was registered for the 2025 Summer Program, you already have an account, however documents must be uploaded each year.*)
3. After logging in, select **My Account**, then Household & Member. Confirm all family members are listed. If needed, select 'Add Family member' at bottom of page and add a child or guardian to the household. Then **save**.
4. Select **Document Upload** from the portal menu and upload your proof or residency (tax or utility bill).
