

Annual Election of the Bethpage Fire District  
December 11, 2018

PLEASE TAKE NOTICE, that the Annual Election of the Bethpage Fire District will take place on December 11, 2018 between the hours of 3:00pm – 9:00pm at the Bethpage Fire District Headquarters located at 225 Broadway, Bethpage, NY, 11714 for the purpose of electing one (1) Commissioner for a five (5) year term, beginning January 1, 2019 and ending on December 31, 2023.

NOTICE IS HEREBY GIVEN that candidates for the office, must file their petition form subscribed by twenty-five qualified voters of the fire district with the District Secretary Mary Jo Bella at the District Office located at 225 Broadway, NY no later than 2:30pm on November 21, 2018. Petitions may be obtained from the District office, Monday to Friday between the hours of 8:00am and 2:30pm. All registered voters of the Bethpage Fire District, who are registered with the Nassau County Board of Elections, on or before November 19, 2018 are eligible to vote in this election.

Please take further notice that the following proposition will be submitted to the voters:

SHALL THE RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE BETHPAGE FIRE DISTRICT IN THE TOWNS OF OYSTER BAY AND HEMPSTEAD, COUNTY OF NASSAU, STATE OF NEW YORK, ADOPTED AUGUST 22, 2018; AUTHORIZING THE AMENDMENT OF THE DISTRICT SERVICE AWARD PROGRAM FOR THE VOLUNTEER FIREFIGHTERS OF THE BETHPAGE FIRE DISTRICT BY CHANGING THE MAXIMUM NUMBER OF YEARS OF FIREFIGHTING SERVICE CREDIT, AS THAT TERM IS DEFINED UNDER SECTION 215 SUBPARAGRAPH (11) OF THE GENERAL MUNICIPAL LAW FROM TWENTY (20) YEARS TO THIRTY (30) YEARS; STATING THE ESTIMATED ANNUAL COST OF SAID PROGRAM AS AMENDED BASED UPON THE PRESENT NUMBER OF FIREFIGHTERS TO BE INCREASED FROM TWO HUNDRED SEVENTY ONE THOUSAND (\$271,000.00) DOLLARS TO THREE HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED TWENTY FOUR (\$322,424.00) DOLLARS; STATING THAT SAID CALCULATIONS ARE BASED UPON THE PRESENT NUMBER OF FIREFIGHTERS REMAINING THE SAME, STATING THAT THE ANNUAL ADMINISTRATION FEE WILL REMAIN THE SAME; STATING THAT THE AMENDMENT WILL APPLY PROSPECTIVELY AND NOT RETROACTIVELY; STATING THAT ALL OTHER PROVISIONS OF THE PLAN WILL REMAIN UNCHANGED AND IN EFFECT; APPROPRIATE SAID AMOUNT THEREFORE, BE APPROVED?
