The letter wasn't included in the paperwork, just says that a letter was sent. Basically, what was done was that it's probably a quarter acre plot in this home, small home. Regular size home in Glen Head and the cleanup was for mowing the grass. For them to be charged \$1,000, 75% of it is administrative fees. I think in this case we have to look at the situation. The people are current on their taxes, and as I said, the home is designated senior citizen and person with disabilities and limited income. I think instead of hitting them with this assessment, someone from our outreach -- we must have

a senior citizens outreach -- should be paying a visit to this home to make sure they're okay before we hit them with a charge like that.

So I'd like you to reconsider adding that \$1,000 charge to this homeowner until which time we can assess their need or their ability to pay.

Uh, the next one I have is on Resolution 34. And as I told Mr. Weber I was going to bring this up. I think the Town has rules set in place for a reason. Special use permits are granted in kind to developers in the good name of the Town. We do it because we think it will benefit everybody involved. This planned hotel development in Jericho was brought to the Board back in 2021. Special use permit was granted. Subsequently, the developer was able to receive benefits from Nassau County IDA. Unfortunately, the special use permit expired sometime on or around August, 2022. If the applicant has failed to renew a request

of a special use permit, they should be told right now that it's expired; it's done. You want a special permit reissued, you should please reapply.

I think the Town has rules and everybody must live by the rules. Even friends of the Town. I say friend because I don't want it to seem -- I got to watch my wording. To get right to the point, Mr. Weber and Weber Law Group are very, very generous with political contributions. According to the Nassau County Board of Elections website, which I looked at last night -- because I haven't had a lot of time to research, and I'm a big believer of following the money -- The Weber Law Group has made substantial contributions to Saladino, Imbroto, Labriola and the Town of Oyster Bay Republican Committee, which benefits the aspirations of all our current board members. It is my feeling that Council persons Saladino and Imbroto should recuse themselves from a vote on this
