**Local Law No. \_\_\_\_\_ of the year 2021**

A LOCAL LAW TO AMEND CHAPTER 233 – TRAFFIC, OF THE CODE OF THE TOWN OF OYSTER BAY.

**Be it enacted by the TOWN BOARD of THE TOWN OF OYSTER BAY as follows:**

**Section 1.** Amend Chapter 233 – Traffic, as follows:

**§17-25 Stop intersections established and enumerated.**

**BAYVILLE**

ADD:

*Through Street*

Entrance to W. Harbor Road Memorial Park  
Hilary Drive

*Stop Street*

W. Harbor Drive, east and westbound  
W. Harbor Drive, east and westbound

**FARMINGDALE**

ADD:

*Through Street*

Vandewater Street

*Stop Street*

Fallwood Pkwy, east & westbound

**HICKSVILLE**

ADD:

*Through Street*

Salem Road  
Nelson Avenue

*Stop Street*

Plover Lane eastbound  
West Marie Street, westbound

**MASSAPEQUA**

ADD:

*Through Street*

Biltmore Blvd.  
S. Biltmore Blvd.  
Peony Drive

*Stop Street*

Hampton Blvd. north spur, northbound  
Biltmore Blvd. westbound  
North Hickory Street, east and westbound

ADD:

*Through Street*

Cold Spring Road

Cherry Lane southbound

**§17-28 “Yield” intersection; erection of signs.**

**MASSAPEQUA**

ADD:

*Through Street*  
Parkside Blvd.

*Yield Street*  
Clark Avenue, northbound spur

**§17-152 No-stopping at any time zones established.**

**BETHPAGE**

DELETE:

*Norcross Avenue* east and west sides starting at the south curb line of Revere Avenue south for a distance of +/- 50 feet.

ADD:

*Norcross Avenue* east and west sides starting at the south curb line of Revere Avenue south for a distance of +/- 150 feet.

**HICKSVILLE**

ADD:

*Spencer Street* – north side – starting at the east curb line of Cliff Drive east for a distance of +/- 35 feet.

ADD:

*Spencer Street* – south side – starting at the east curb line of Cliff Drive, east for a distance of +/- 35 feet.

ADD:

*Cliff Drive* – east side – starting at the north curb line of Spencer Street, north for a distance of +/- 35 feet

ADD:

*Cliff Drive* – east side – starting at the south curb line of Spencer Street, south for a distance of +/- 35 feet.

ADD:

*Plainview Road* – south side – starting at the west curb line of the entrance to Triangle Park, west for a distance of +/- 30 feet.

ADD:

*Plainview Road* – south side – starting at the east curb line of the entrance to Triangle Park, east for a distance of +/- 30 feet.

ADD:

*Plainview Road* – south side – starting at a point +/- 30 feet west of the west curb line of the entrance to Triangle Park, west for a distance of +/- 40 feet.

ADD:

*Plainview Road* – south side – starting at a point +/- 30 feet east of the east curb line of the entrance to Triangle Park, east for a distance of +/- 40 feet.

## MASSAPEQUA

ADD:

*East Shore Drive* - west side – starting at the south curb line of S. Merrick Road south for a distance of +/- 35 feet.

DELETE:

*North Idaho Avenue* – north side – starting at the east curb line of North Baldwin Drive, east for a distance of +/- 465 feet.

ADD:

*Commonwealth Avenue* – north side – starting at the west curb line of Hicksville Road west for a distance of +/- 35 feet.

ADD:

*Commonwealth Avenue* – south side – starting at the east curb line of Hicksville Road east for a distance of +/- 35 feet.

ADD:

*Commonwealth Avenue* – south side – starting at the west curb line of Hicksville Road west for a distance of +/- 45 feet.

## OYSTER BAY

DELETE:

*Summit Street*, on the south side, starting at the east curb line of South Street, east for a distance of +/- 30 feet.

ADD:

*Summit Street*, on the south side, starting at the east curb line of South Street, east for a distance of +/- 40 feet.

## SYOSSET

ADD:

*North Street* – west side – starting at the north curb line of Church Street north for a distance of +/- 45 feet.

**§17-165**      **Locations at which parking is prohibited at any time; sign posted.**

## MASSAPEQUA

ADD:

*South Merrick Road* – north side - starting at a point +/- 170 feet east of the east curb line of Unqua Road east for a distance of +/- 60 feet.

ADD:

*Beverly Place* – east – side starting at a point +/- 190 feet north of the north curb line of Hampton Blvd. north for a distance of +/- 50 feet.

**§17-166**      **Locations at which parking is prohibited on certain days and hours.**

## GLEN HEAD

DELETE:

NO PARKING 8 PM TO 3 AM FRIDAYS AND SATURDAYS

*Benjamin Street* – west side – starting at a point +/- 100 feet south of the south curb line of Glen Head Road, south to School Street.

ADD:

NO PARKING 8 PM TO 3 AM FRIDAYS AND SATURDAYS

*Benjamin Street* – west side – starting at a point +/- 100 feet south of the south curb line of Glen Head road, south for a distance of +/- 70 feet.

ADD:

NO PARKING 8 PM TO 3 AM FRIDAYS AND SATURDAYS

*Benjamin Street* – west side – starting at a point +/- 245 feet south of the south curb line of Glen Head Road, south to School Street.

**MASSAPEQUA**

DELETE:

NO PARKING 10 AM TO 5 PM

*Rhode Island Avenue* – north side – starting at a point +/- 144 feet west of the west curb line of Broadway west for a distance of +/- 65 feet.

ADD:

NO PARKING 10 AM TO 5 PM

*Rhode Island Avenue* – north side – starting at a point +/- 144 feet west of the west curb line of Broadway west for a distance of +/- 104 feet.

**SYOSSET**

DELETE:

NO PARKING 8 AM TO 10 AM EXCPET SAT. SUN. & HOLIDAYS

*North Street* – west side – starting at the north curb line of Church Street, north for a distance of +/- 160 feet, to the property line of house number 29.

ADD:

NO PARKING 8 AM TO 10 AM EXCPET SAT. SUN. & HOLIDAYS

*North Street* – west side – starting at a point +/- 100 feet north of the north curb line of Church Street, north for a distance of +/- 55 feet.

DELETE:

NO PARKING 8AM TO 10AM EXCEPT SAT. SUN. & HOLIDAYS

*Ira Road* – south side – starting at the east curb line of Nathan Court east to the west curb line of Fifth Place.

ADD:

NO PARKING 8AM TO 10AM EXCEPT SAT. SUN. & HOLIDAYS

*Ira Road* – south side – starting at the east curb line of Nathan Court east for a distance of +/- 200 feet.

ADD:

NO PARKING 8AM TO 10AM EXCEPT SAT. SUN. & HOLIDAYS

*Ira Road* – south side – starting at a point +/- 290 feet east of the east curb line of Nathan Court east to the west curb line of Fifth Place.

**Section 2. SEQR Determination.** It is hereby determined pursuant to the provisions of the State Environmental Quality Review Act, (SEQR), 8 N.Y.E.C.L. Section 0101 et seq. and its implementing regulations, Part 617 of 6 N.Y.C.R.R., that the adoption of this local law is a “Type II” Action within the meaning of Section 617.5 (c) (26) of 6 N.Y.C.R.R., pertaining to “routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment” and, accordingly, is of a class of actions which does not have a significant effect on the environment and no further review is required.

**Section 3. Severability.** If any section, subdivision or provision of this local law or the application thereof to any person or circumstance be adjudged invalid by a court of competent jurisdiction, such judgment shall be confined in its operation to the section, subdivision or provision of or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this local law, or the application thereof to other persons or circumstances.

**Section 4. Effective Date.** This local law shall take effect immediately upon its adoption and filing with the Office of the Secretary of State.
