We are taking a vote, among other

things, to adopt our 2024 Budget. We held our morning and evening meetings, our hearings on this budget in our last budget meeting. This budget for 2024 freezes town property taxes for the sixth time, the sixth time consecutively in spite the national economy experiencing the highest inflation rate in at least 40 years.

This budget continues to sustain the \$1.3 billion of property tax cut approved by this Town Board for 2018. That means \$9.3 million, \$9.3 million is back in the pockets of our taxpayers, rather than in the coffers of Oyster Bay Town government. This tax freeze is once again possible due to spending restraints and efficiencies, debt reduction initiatives, and many of the initiatives that this Town Board has put into place.

The budget continues to pay down our town debt. We have paid off a net of 25% of our town's capital debt, reducing it by a net of \$187 million, while still

paving over a third of our roads, all of the bridges, all of the capital work that we're doing, we're very, very proud of that.

We had an ongoing budget deficit before we came to the Town of Oyster Bay of \$44 million. Yes. A \$44 million multi year budget deficit. That's been turned around immensely and we now have an \$88 million surplus on our ongoing budget.

We have fully balanced every single aspect of our budget. All 13 of the budgets within our overall budget are fully balanced and there is no borrowing for cash flow purposes. Our successes go on and on and on.

People have heard of them: notches of increases that we've received in our bond rating, 12 notches over the course of eight different critical times when Wall Street told us that we're doing a great job and we're all very, very proud of that.

And finally, not finally, but the

last thing I'll mention on a very long
list of accomplishments, the New York
State Comptroller, Tom DiNapoli, gives a
rating to every municipality in New York
state. It's on a scale of 0 to 100, with
100 being the worst. Back in 2017, we
were the fourth worst municipality in the
state of New York on that scale. In
2000, our numbers started with critically
high numbers ratings like 91, which is a
terrible rating to have.

Our 2022 number was just released about a month ago by the State

Comptroller's office, and our score is zero; zero fiscal stress in the Town of Oyster Bay. With all of these accomplishments, with all of the improvements to the qualities of the services and to all of the capital improvements from bathrooms to turf fields to road work to bridges to the infrastructure of our town and the list goes on and on.

So today we'll be voting to pass
