2 SUPERVISOR SALADINO: Ladies and 1 2 gentlemen, if you'll all be seated. 3 Welcome to our Oyster Bay Town Board 4 meeting for Tuesday, November 20, 2018. 5 We are wishing each and every one of you and your loved ones a very healthy and Happy 6 7 Thanksgiving. 8 Good evening and welcome to Town Hall. 9 To lead us in prayer, please welcome 10 Rabbi Jay Weinstein of Simchat HaLev in Syosset. 11 Rabbi? 12 (Whereupon, a prayer was recited by 13 Rabbi Jay Weinstein.) 14 SUPERVISOR SALADINO: Thank you, Rabbi, 15 and thank you for being such a good friend. 16 God bless you and your family and all 17 in your congregation. 18 Please remain standing and join us in 19 welcoming a very distinguished United States Navy 20 veteran, Richard Cardone of Farmingdale, to lead us 21 in the Pledge of Allegiance. 22 Richard had the -- was a second class 23 petty officer during the Korean conflict and he served from 1951 to 1955. 24 25 Richard Cardone, while serving on a

3 1 cargo vessel, was the recipient of a lifesaving 2 medal for pulling two crew members to safety. 3 Our American military is known for its 4 courage. This is part of what makes the men and 5 women of the United States Armed Services the finest in the world. 6 7 How about a round of applause for Richard? 8 9 (Applause.) SUPERVISOR SALADINO: Mr. Cardone? 10 11 (Whereupon, the Pledge of Allegiance 12 was recited by Richard Cardone.) 13 SUPERVISOR SALADINO: Thank you very 14 much. You all may be seated. 15 Mr. Cardone, we can't thank you enough 16 for your dedication and your service to our nation. 17 Your work is exceptional and it sets the bar for 18 everyone. You're one of our hometown heroes, and 19 we thank you for your service. 20 Now, please join me all in remembering, 21 not only Mr. Cardone, but all of our veterans. 22 Please join me in remembering all of you who have 23 sacrificed so we can be free. God bless you, God 24 bless all of our veterans, those here and those who 25 cannot be here. God bless everyone in law

| 15 | need the support and help of all of us.             |
| 16 | Team YOLO is an acronym for You Only                |
| 17 | Live Once. It's a group founded five years ago by   |
| 18 | Dani Taylor, who is a mom and from Oyster Bay. The  |
| 19 | group is made up of primarily moms from the Town of |
| 20 | Oyster Bay, but it is open to everyone.             |
| 21 | Team YOLO routinely competes in                     |
| 22 | obstacle course running events to raise money and   |
| 23 | awareness for the Morgan Center. And the Morgan     |
| 24 | Center, we're very proud of the Morgan Center, and  |
| 25 | that is a preschool for children with cancer and    |

5 1 it's located right here in the Town of Oyster Bay 2 in Hicksville. 3 To tell us more about Team YOLO, I'd 4 like to call upon Councilwoman Michelle Johnson, 5 who has, over the years, developed a very close relationship with the members. 6 7 Councilwoman? 8 COUNCILWOMAN JOHNSON: Thank you, 9 Supervisor. 10 I've always been inspired by Team YOLO, 11 and one might think that they are a regular group 12 of local woman who've banded together to achieve 13 something extraordinary, but they're not a regular 14 group. They are just extraordinary. 15 They are working moms, they're single 16 moms, maybe they're not moms, but what they do and 17 what they give back to our community is 18 immeasurable. 19 Not too long ago, members of Team YOLO 20 were asked to be guests on the Ellen DeGeneres show 21 held in Los Angeles. 22 This group of moms took that once in a 23 lifetime opportunity and decided to further build 24 awareness to the Morgan Center and provide details 25 with how people can support this organization's

6 incredible work. 1 2 The Town of Oyster Bay has an extremely 3 close bond with the Morgan Center because they're based locally, as the Supervisor said, out of the 4 Town's Athletic Center in Hicksville. 5 The Morgan Center operates in our 6 7 facility and provides preschool aged children 8 battling cancer the opportunity to learn and 9 socialize in a safe environment. 10 Children undergoing chemotherapy 11 treatment have suppressed immune system and the 12 Morgan Center allows these children to interact in 13 a setting where all of the parents understand the 14 inherent risks and the importance of a germ-free 15 environment and limiting exposures. 16 It's hard not to be touched by the 17 uplifting work being done there. The Morgan Center 18 is provided free of charge to the children and 19 their family. Tuition and expenses are completely 20 supported by private donations and fundraising. 21 That's why the generosity and the kindness of 22 people like the people on Team YOLO should be 23 celebrated. 24 Thank you, Supervisor, for the 25 opportunity to say these words. I just want to

7 say, we have the YOLO kids in the audience. 1 2 Could you guys all stand up, please? 3 (Applause.) COUNCILWOMAN JOHNSON: And this is 4 5 just, I think, a small percentage, but they have 6 such wonderful strong moms and support systems 7 teaching them to do the right thing and we're so 8 happy you guys are part of our community and are 9 growing up here and will come back give back to us 10 just like your moms are doing. 11 Thank you. 12 SUPERVISOR SALADINO: Thank you. 13 (Applause.) 14 SUPERVISOR SALADINO: And representing 15 Team YOLO is Dani Taylor. 16 Dani, would you like to come up and 17 speak to us about Team YOLO and all of your 18 endeavors? 19 COUNCILWOMAN JOHNSON: And maybe Dani 20 could tell us what you guys, I think, did last 21 weekend, was it, and what you guys do in general? 22 Notice how fit Dani is. 23 MS. TAYLOR: Good evening. 24 Thank you, everybody, for having us. 25 We really appreciate this opportunity.

8 My name is Dani Taylor and I am the 1 2 cofounder of YOLO Strong Foundation. 3 I know all of you, from time to time, 4 I'm sure, are faced with people coming to you with 5 various complaints. I'm here tonight to just tell you, as I'm sure you already are, by how amazing 6 7 our Town is, not just because of the people, the 8 women that stand with me and race with me, not just 9 because of the children that have raCED also, but 10 the people who have supported us in our endeavor to 11 help special needs children and children that are 12 ill here in the Town of Oyster Bay. 13 As you mentioned, Councilwoman Johnson, 14 that we started six years ago and our mission was 15 to help children at the Morgan Center. About a 16 year ago, we decided that we were able to make an 17 impact on those children and we wanted to continue 18 to do that with other children here in the Town of 19 Oyster Bay. 20 We decided to become our own 501(C)(3) 21 and decided to take on other causes. In addition 22 to providing preschool for children with cancer or 23 who are undergoing chemotherapy, we decided that 24 were going to provide iPads for noncommunicative 25 poor children here in Oyster Bay.

9 1 We also decided that we were going to 2 provide financial help for families who are dealing 3 with an unforeseen illness of a child or a death of 4 a child. And we also decided that we were going to 5 provide medical devices for medically fragile The reason why we wanted to do this is 6 children. 7 because we understand that we are lucky. None of us have children that are sick. 8 9 None of us have to deal with this. So every year, 10 we go off and we do our obstacle course race and, 11 of course, we have goals, and my dad, when living, 12 has always taught me, never forget where you come 13 from. 14 About a year ago year, a year and a 15 half ago, we were presented with our first citation 16 or award, and it was from all of you, which we were 17 all humbled by that. 18 And since then, we were even more 19 determined to make sure that we were going make an 20 impact and try to tell you what impacts we've been 21 able to make to the families and children in this 22 Town. We had it in our sights to get noticed by 23 Spartan, which is one of the most elite obstacle 24 course race companies. 25 And although it seemed like a huge feat

| 2  | back. We spoke with them. We didn't hear from       |
| 3  | them. We thought, well, maybe not this time, and    |
| 4  | then they called us. We had just done a race at     |
| 5  | the City Challenge in Hoboken, New Jersey, and they |
| 6  | asked us to be their charity partner at their first |
| 7  | Long Island race last weekend.                      |
| 8  | In next to no time, we managed to put               |
| 9  | together a team of 127 adults and 49 children. A    |
| 10 | month before that, we had 52 women. We did decide   |
| 11 | to let the dads join us for this one. Their         |
| 12 | challenge to us was to put together the largest     |
| 13 | team and we were a little nervous about it, but we  |
| 14 | did it.   |
| 15 | So Spartan announced us as the largest              |
| 16 | team at Bethpage Restoration Park, and we couldn't  |
| 17 | have been prouder. The thing that I was most proud  |
| 18 | of on this journey, because it isn't always a       |
| 19 | destination, is the fact that we had moms and dads, |
| 20 | aunts and uncles who decided to go on a completely  |
| 21 | uncomfortable journey and put themselves out there, |
| 22 | all for the sake of local children.                 |
| 23 | We have these children, who you see                 |
| 24 | here, who decided to fill up water bottles with     |
| 25 | dimes, and to date, they raised close to \$400 in   |

11 dimes. One child even started her own Go Fund Me 1 2 page. These children were just amazing. They were 3 energetic, they were training, they showed up, and 4 they understood that they're lucky and their 5 families are lucky because they don't have to go through this. 6 7 These are the people that live in our 8 Town. We were supported by multiple local 9 businesses, Mill Neck Manor, Sterling Bank, Testa 10 Wines, Locust Valley Boys and Girls Club, Firm, 11 Dells, Purolator, Oyster Bay Karate, Mossimo Auto 12 Body, Homestead, United Paving, Coach, Cafe 13 al Dente are just a few of some of the businesses 14 here in Oyster Bay that supported us. They were 15 sponsors, which means that they donated \$500 or 16 more, and they were on the back of our shirts. 17 What I wanted to say is thank you. 18 Thank you for supporting us in the very begin ing. 19 Thank you for standing by us. Thank you for always 20 giving us a chance. Thank you for saying hello 21 even when you see us. Thank you for entering our 22 50/50, Lou, last week. 23 COUNCILMAN IMBROTO: I didn't win. 24 MS. TAYLOR: I know you didn't. 25 Thank you for believing in us and

12 supporting us. And, of course, if there was ever 1 2 an opportunity for a race to happen here in Town of 3 Oyster Bay, maybe in Tobay, we would love to be a team that holds it. 4 5 Thank you. 6 (Applause.) 7 SUPERVISOR SALADINO: Thank you for those kind words, and on behalf of all of us in 8 9 Town government, we are looking forward to 10 continuing the great relationship with Team YOLO. 11 So, Dani, before you sit down, if you'd 12 come back up, if you don't mind, we have a Town 13 Citation for all of you, and I'll ask that 14 Councilwoman Johnson make this presentation while 15 all of us come and join. 16 COUNCILWOMAN JOHNSON: Maybe all the 17 moms that are here that participated can come up. 18 I don't know if we can fit the kids in. Everyone 19 up. 20 COUNCILMAN IMBROTO: We'll make them 21 fit. 22 (Whereupon, a Town citation was 23 presented.) 24 SUPERVISOR SALADINO: Let's hear it 25 again for Team YOLO.

13 1 (Applause.) 2 SUPERVISOR SALADINO: More news, the 3 Town of Oyster Bay recently collected DVDs for 4 donation to our military, which is a new and unique 5 program that supports our servicemen and women overseas, and to quote Councilman Macagnone, it's 6 7 good stuff. 8 These monies will provide entertainment 9 to our brave men and women in uniform and give them 10 the opportunity to relax and enjoy an activity 11 that, quite frankly, so many of us take for granted 12 here at home. The donations will be delivered to 13 14 chaplains, commanding officers, sergeant majors and 15 sergeants to distribute to troops, and this way, 16 they can arrange movie nights and bring them a 17 little closer to home and to the activities we 18 love. 19 Tonight, we're proud to recognize two 20 Town residents, Arthur Strachman of Massapequa and 21 Ronny Ciarniello, of Bethpage for their exceptional 22 efforts behind making this program so successful. 23 For more than sixteen years, Arthur and 24 his family have coordinated the military DVD 25 program and were responsible for the collection and

TROTTER: I just want to thank Joe 5 for posting all your things on Facebook because thanks to your posting, what happened, this DVD 6 7 drive, that's how we got the idea to do it in the 8 school. And the previous drive that we had for the 9 soldiers, we were collecting items, we also did 10 that drive in our school. 11 SUPERVISOR SALADINO: That was unified 12 by Councilman Macagnone and all of our Town Board 13 members. 14 MS. TROTTER: The fact that you post 15 all these things, we kind of just piggybacked off 16 of it. It was great. 17 I also got to miss my parent/teacher 18 conferences tonight and we're here again because 19 the Principal gave me permission. He thought this 20 could be a very worthwhile thing to do. 21 And I have another conference night in 22 December, so we'll see what happens. But, yes, he 23 was very happy for us to come to this and, you 24 know, for the Town. 25 SUPERVISOR SALADINO: Thank you for

16 1 being here. 2 Kids, do you know what the motto of 3 Kiwanis is? We build, and we build can mean many 4 things, build relationships in the community, build 5 a better community, and we build -- a community can go across the ocean to our men and women in service 6 7 to our military on the other side of the world. 8 So we will continue to work together 9 and build together. I'm a 30-year member of 10 Kiwanis. I was Kiwanis president way back when, 11 very proud of that, and we hope each and every one 12 of you will continue on with the Kiwanis Club as 13 you age and continue to build in the community. 14 Thank you. Thank you all for being 15 here. 16 (Applause.) 17 MR. CIARNIELLO: I wanted to bring 18 something special because, frankly, the 19 Supervisor's office has done far, far more than I 20 had hoped for, which is pretty unusual because I 21 usually ask for too much. But I had expected him 22 to do collection for about a week or two, he did it 23 for two months, and I had expected it to basically 24 just be collected out of one location. It was 25 collected out of four locations and a lot of groups

17 1 joined in on it. 2 So I wanted to make a presentation as 3 well. And let me explain to you what I'm 4 presenting. The best gift you can get from a 5 soldier is a certified flag, and what that means is, is it's certified to have gone on a mission and 6 7 they have to go through a lot of work to get the 8 flag. It has to go in a plane or a tank or over a 9 camp or something along those lines, and then, of 10 course, they have to mail it to us. 11 My father, throughout the years, was 12 lucky enough to get 21 of these flags, but each one 13 of these flags is special onto its own. And I 14 brought the certification, as well as a short note, 15 from the first military mental health hospital and 16 hospital that we supplied DVDs to. It was in 17 Cutter or Qatar -- I'm not sure exactly how to say 18 it -- and they had two very large hospitals and 19 they had a base of about 10,000 troops in that 20 particular location. 21 And the first of, I would say, seven 22 hospital directors that we worked with sent us this 23 certification and it -- also this letter. And, of 24 course, was mailed to my father. 25 And the subject is, "Thank you for your

18 continued support of our deployed warriors." 1 2 "Dear Big Hy, As a deployed airman, I 3 am honored to be able to offer to you, a flag flown 4 in a deployed aircraft on a combat sortie. I could 5 think of no one more deserving than you of this flag and no one who understands what this flag 6 7 stands for and means to our veterans. 8 "Please find a flag enclosed with a 9 certificate signed by the squadron commander. This 10 flag was flown on the 28th of February 2012 in a 11 B-2 bomber during a combat mission over 12 Afghanistan. 13 "Thank you for all you've done." 14 Sincerely -- and the Gen. Scott Krebs, 15 was the head of the hospital. 16 So, I mirror exactly what he says. Ι 17 want to thank the Supervisor for all he's done, and 18 in honor of what he's done, in honor of my father's 19 service, in honor of his father's service, I'm 20 presenting the certified flag, certificate and 21 letter, and he's welcome to put it wherever he'd 22 like. 23 I thank you very, very much. 24 (Applause.) 25 SUPERVISOR SALADINO: I'd like to thank

19 1 you very, very much for this incredible honor. 2 And I accept this on behalf of all of 3 my colleagues on the Town Board, the Town 4 employees. We all work as one unit to do 5 everything possible to help our community, to lead 6 people in the right direction and to continue to 7 respect and honor those who came before us and 8 those who have sacrificed in so many different ways 9 for our community. Thank you for mentioning my father, a 10 11 proud member of the United States Marine Corps, who 12 served in Korea, not once, but twice. We all have those stories. This is a tremendous honor which I 13 14 share with all of my colleagues. 15 (Applause.) 16 SUPERVISOR SALADINO: It would also be 17 our honor to fly this flag here at Town Hall on 18 occasion to honor veterans. 19 MR. CIARNIELLO: Wonderful. 20 SUPERVISOR SALADINO: Thank you very, 21 very much. 22 God bless you. 23 (Applause.) 24 SUPERVISOR SALADINO: Very, very 25 special.

7 1 This option became available to MercyFirst due to 2 recent changes in New York State law, which raised 3 the age for juveniles and bans offenders up to 4 17 years old from adult correction and detention 5 facilities. Last week, we heard from dozens of 6 7 residents living near and around the facility, of 8 safety concerns related to robbery, trespassing, 9 criminal mischief, disorderly conduct and other 10 serious matters. 11 In fact, we learned from the Nassau 12 County Police Department that nearly 1,300 calls 13 have been made to police regarding this facility 14 since 2016, the highest concentration of 911-15 related calls anywhere in the Town of Oyster Bay. 16 Also, last week, code enforcement 17 officials visited MercyFirst after learning of 18 nonpermitted construction taking place on the 19 property. 20 Inspectors from the Town of Oyster Bay 21 Department of Planning and Development issued 22 Notices of Violation and Stop Work Orders against 23 the facility for commencing work related to housing 24 these new detainees without Town approval. 25 As your representatives in Town, we

We await some guidance 13 from the State with regard to the forthcoming DRI 14 funding to see how those \$200,000 might best 15 leverage that opportunity. 16 But we do welcome the opportunity to 17 meet with Mr. Molinari, the Hicksville Downtown 18 Revitalization Committee and learn their thoughts on how that \$200,000 might best be utilized. 19 20 SUPERVISOR SALADINO: It's important to 21 point out that Mr. Molinari is a member of that 22 committee. 23 DEPUTY COMMISSIONER BELL: Of course. 24 SUPERVISOR SALADINO: And has been 25 active with this process from the very beginning.
