Each bid must be prepared and submitted in accordance with the Instructions to Bidders and must be accompanied by Bid Security in the form of a certified check, bank check, or bid bond in the amount of five percent (5%) of the total amount of the bid.

Contract documents are available for review and procurement at the Division of Purchase and Supply of the Town of Oyster Bay at Town Hall West, 74 Audrey Avenue, Oyster Bay, New York, 11771-1592, on or after **October 21, 2024** between the hours 9:00 a.m. and 4:00 p.m., on regular business days, Monday through Friday. A charge of **FIFTY DOLLARS (\$50.00)** payable to the Town of Oyster Bay, non-refundable, will be required for the set of contract documents. In submitting a proposal hereunder, a Contractor is required to comply with all applicable provisions of Federal, State and Local Laws.

In accordance with Section 220 of the New York Labor Law, all public works contracts in excess of \$250,000.00 require that all laborers, workers and mechanics working on the site be certified as having successfully completed the OSHA 10-hour construction safety and health course.
