The Town of Oyster Bay is requesting the submission of resumes of qualified attorneys who wish to serve on the Employee Relations Hearing Officers Panel. Such hearings are usually conducted at 9:30 a.m., Monday through Friday. Hearings are held at the Town of Oyster Bay Department of Public Works CSEA Conference Room, 150 Miller Place, Syosset, New York. Occasionally, hearings may be held at Oyster Bay Town Hall South, 977 Hicksville Road, Massapequa, New York or Oyster Bay Town Hall North, 54 Audrey Avenue, Oyster Bay, New York.

The hearings address whether an employee has violated the Contract between the Town of Oyster Bay and CSEA, or the work rules of the several departments, and what punishment, if any, should be imposed upon the employee. The hearings are conducted pursuant to Section 75 of Civil Service Law of the State of New York.

Background in employee relations or similar matters, including courtroom or prosecutorial experience, is considered in the selection process for the Town of Oyster Bay Hearing Officers Panel.

The compensation rate for a Hearing Officer is \$350.00 per hearing.
